Re: Work projects for Unit Owners / Potential Contractors List

Dear Bristol Tower Residents,

In order to maintain the availability of Association employees for regular work schedules and avoid hiring additional employees, the Finance Committee has recommended and the Board of Directors have approved a resolution that states: "Association employees will only be available for unit owner work projects on an independent contract basis, between 4:30 PM and 9 AM on weekdays, and on Saturday and Sunday from 9 AM to 4 PM, except in the case of an emergency which will be determined by Management."

According to our management company, FSR, this new policy brings Bristol Tower in line with over 95% of the condominiums in the Miami area, including our sister condo, Santa Maria—most of which do not permit their employees to work on unit owner's projects at any time.

In order to help our unit owners with this transition to a more normal way of getting their work projects done during the day, we have developed a list of handyman contractors who are licensed and approved for work in our building.

Attached is a list of companies that have provided the management office with the required license and insurance coverage on prior occasions to perform work within a unit or at the building. The Association does not endorse or recommend any of the companies attached and makes no representation concerning the quality of these companies or the work they perform. The Association is not legally or otherwise responsible for the actions of these companies. This list of companies is being provided for convenience purposes only. Owners are not required to use a company on the attached list and have the responsibility of selecting any company they so desire to perform work within their units. Although each company must provide a copy of its certificate of insurance every time they come to work on property to ensure that the coverage is sufficient and approved by the Association. Prior to the commencement of any work within a unit, the company performing the work, including those companies listed below, certificate(s) of insurance, license(s) and the scope of work must be approved in writing by the Association.

The management office will be able to determine if the scope of work is subject to approval by the Board of Directors, and if applicable additional information and documentation will be required. Please contact the management office if you have any questions or concerns at 305-856-2200.

- General liability: must have additional insurance (marked with an x or y)
- Workers compensation: required (workers comp exemption is NOT accepted)
